

RAFFLE MAYNIA! - OFFICIAL RULES

1. DESCRIPTION: The Raffle Maynia! ("Raffle") ticket sales begin on April 1, 2022, at 12:01 am CST and end on May 27, 2022, at 11:59 pm CST or until 500 tickets have been sold (the "Promotion Period").

By participating in the Raffle, each Entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and Sponsor's decisions, which shall be final and binding in all respects. The Sponsor is responsible for the collection, submission, or processing of Entries and the overall administration of the Raffle. 2. ELIGIBILITY: Open to legal residents of MISSOURI who are 18 years or older (the "Entrant").
